A Zoom meeting was called to order by President Kevin Miller at 4:00 pm. The Board considered the meeting minutes from April 6<sup>th</sup>, 2021. The minutes were approved as originally electronically distributed.

Brett presented the treasury report. The net ordinary income for the months of April through May 2021 was at a positive \$8,569.39. Brett reported that the Association had 5 townhomes in the arrears.

## Old Business:

- 1. Updates on spraying trees on Chileno Dr. Brett will watch to see if it is needed to spray the trees.
- 2. Update on spraying the clover. One application has been made and will follow up if another is needed.

- 3. Update on garage sale and welcoming committee. The garage sale was a success and the committed did a nice job. Roger stated the welcoming committee is going well.
- 4. Update on horizonal boring: Brett is getting pricing.
- 5. Update on dead trees:
  - A. Along 40<sup>th</sup> street: Brett will get an update on this street.
  - B. 3841Pablo Dr: Will replace tree and reseed the grass.
  - C. Behind Palmilla Lane: Trees were taken down.
  - D. Pine trees behind Josephine's townhome on Pablo Dr: These trees are not he responsibility of the Association.
- 6. Water drainage on Chileno Dr between townhomes is difficult to mow. Brett will work on a solution for this issue.
- 7. Water curb box casting cover in front of 3820 Cabo Dr.
  Brett will look at the problem and see if there is anything that can be done.
- 8. Adam K9 was contacted to clean up the feces behind 3804 Cabo Dr. The company came out 4 time in late May. Kevin will check with the owner for payment.
- 9. Concrete repair of curbs at 3849 Cabo Dr. Brett will have it repaired.
- 10. Parking violations: Kevin will be sending a letter to owner of rentals.
- 11. Siding repair at 3828 Cabo Dr: Kevin is requesting \$375.00 payment for the repair. On a motion by Keith Prettyman and seconded by Zandra Uhrmacher the request was approved.

## **New Business:**

- Disseminate notice to affected Pablo Dr and Cabo Dr residents concerning the planting of trees in common area. Kevin will be sending a letter out stating the Board did not approve.
- 2. Potential break-in of irrigation timer: Brett will be checking in on the boxes.
- 3. Return to in person board meetings: It was decided to do two in person meetings a year and the rest would be Zoom meeting.
- 4. Potential sprinkler blockage at 3848 Cabo Dr: Brett will check to see if there is anything we can do with the sprinklers.
